



Summary of Changes to the Hallmark Capital Management, Inc. (“Hallmark”) Form ADV Part 3 (Form CRS)

In accordance with regulatory requirements, Hallmark is providing the attached copy of its amended Form ADV Part 3 (Form CRS) as of July 5, 2022, for your records. Hallmark has revised its response to the question, *“Do you or your financial professionals have legal or disciplinary history?”* from “No for our firm. Yes, for our financial professionals” to “No.”

This change has been instituted to reflect the removal of a previously disclosed disciplinary item from 2002 for a Hallmark Investment Advisor Representative (“IAR”). The disclosed item was the result of an incorrect response on an initial filing of a Form U4 (Uniform Application for Securities Industry Registration or Transfer).

INTRODUCTION

Hallmark Capital Management, Inc. (“our,” “we,” or “us”) is an investment adviser registered with the U.S. Securities and Exchange Commission (“SEC”). **Brokerage and investment advisory services and fees differ, and it is important for you to understand the differences.**

RELATIONSHIPS AND SERVICES

What investment services and advice can you provide me?

We offer personalized investment management services to retail investors by giving you continuous advice and making investments for your account based on your individual investment goals. We also offer financial planning services, either pursuant to a written financial plan or on a consulting basis. As a standard part of our investment management services, we monitor the investments in your portfolio on a continuous basis. We will contact you (by phone or e-mail) at least annually to discuss your portfolio and to see if there are any changes in your financial circumstances and investment guidelines. You can choose an investment management account that allows us to buy and sell investments without asking you in advance (a “discretionary account”) or we may give you advice and let you make the ultimate decision regarding the purchase or sale of investments (a “non-discretionary account”). To establish an investment management relationship with us, we require a minimum account size of \$500,000, although we may waive this requirement under certain circumstances. There are no account minimums for our financial planning and consulting services.

FEES, COSTS, CONFLICTS, AND STANDARD OF CONDUCT

What fees will I pay?

We charge an asset-based fee for our investment management services quarterly in advance. At the start of each financial planning engagement, 50% of the estimated total fee is due with the balance due upon completion and delivery of the financial plan or specialized analysis. *Regarding our asset-based fee, the more assets that are in your account, the more you will pay in fees and therefore, we may have an incentive to encourage you to increase the assets in your account.*

In addition to our advisory fees, you may be responsible for paying some, or all of the following types of fees:

- Fees paid to the custodian that holds the assets in your account
- The fees paid to managers of the mutual fund(s) that are selected for your account
- Transaction fees when an investment is bought or sold for your account

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investment over time. Please make sure you understand what fees and costs you are paying.

Our financial professionals are paid a salary and are eligible to receive an annual bonus related to the revenue generated by the client assets they obtain and service. This arrangement may create an incentive to place client assets in equity portfolios that generate higher fees. We have controls to review client guidelines and portfolio choices to mitigate this risk. Hallmark is compensated solely by fees paid by its clients and does not receive commissions or compensation from any other source, i.e., mutual funds, insurance products or any other investment product.
